

We had a good amount of participation on the Vanco App, which is also, administratively, very easy to access and use. We had 12 members use that method of offering in the year 2024. We had 33 Zion members that deposited traditionally in 2024. Zion also received 5 memorials in 2024. We raised for the carpet project and received both free-will, open, and 'square' purchases to completely fund that, and hosted our Thanksgiving community meal, a successful, free-will donation, event.

2024 Year-end statements were totaled, alphabetized and placed at the church from 01/15/2025 through 01/20/2025. The remaining statements will be mailed at this time to ensure January 31st delivery.

I have come to the end of my 3-year term with the council. I will wait until after election and meet the member taking over to go through each of the facets of this position.

Greetings to Kulm Zion Lutheran members.

I would like to thank everyone for the successes of Zion Lutheran this past year. We can reflect back at the role our church has had for each of us, our families, and the community this past year.

Some of the highlights include an active SWAG (Saved With Amazing Grace), youth group, confirmation class, church women's group, community thanksgiving meal, Christians In Action consortium, and more. I appreciate the willingness of our members to take active roles making these activities possible.

Physical improvements for the church include re-siding the church parsonage along with replacing the front steps. This was the final stage for the two-year remodel project. The fellowship hall has been changed over to LED lighting, reverse osmosis filtering has been installed in the church kitchen, and finally, new carpeting for the fellowship hall; it is scheduled for February.

The final point I would like to bring forth is the financial position of our church. As everyone is aware costs continue to rise. The expenses for the church are no different. Having the benefit being served by a pastor is not to be taken for granted and having one who's family is living in and active in the community is even better. Having that blessing is not without financial obligations.

The church has taken on several projects over the years to improve the church and our members have stepped up and raised the funds for them. A prime example is the new carpeting of the fellowship hall. The cost for the project has been fully covered by the many donations from our members and friends. It reflects on a strong and committed membership.

The church has been operating with a shortfall of income to cover our expenses and has needed to make withdrawals from the endowment accounts to make up the difference. This has worked well but we can not expect the endowment funds to carry a majority of our church budget. Now is also a good time to stress the important role the endowments will have in continuing the missions of our church. Please remember the church's endowment accounts and consider gifting money into them. The gift is not spent but kept in the endowment and the interest is available to be used for the needs of the church. This allows the giver's legacy to continue benefiting the church for years to come. This is something to consider also with wills and estate planning.

Please keep the needs of the church in your prayers and let's continue building on our strengths. Thank you again.



ZION LUTHERAN CHURCH, KULM, ND SLM'S ANNUAL REPORT FOR 2024

Thank you to everyone for your encouragement and support in 2024! Thank you to each and every one of you who helped in any way as we continue to be God's hands and feet in this world. Your time and talents are greatly appreciated! I thank God for Pastor Linda as she continues to serve as our pastor and am grateful to be working together as Zion Lutheran Church continues to carry out God's Mission in the world.

Pastor Linda, Rhonda Benton, and I attended the EaND Synod Assembly on June 1 and 2. Summary of the 2024 Synod Assembly: On June 1-2, 2024, the Eastern North Dakota Synod, ELCA gathered together at the Holiday Inn in Fargo, ND for the thirtyseventh annual Synod Assembly under the theme of "Challenge: Learn, Discern, Respond." There were a total of 296 people in attendance (183 Lay Voting Members; 80 Rostered Minister Voting Members; 33 Visitors). The business items included hearing reports from officers, adopting the 2025 Synod Mission Plan (budget), elections for Synod Council, Committees, and Voting Members to the 2025 Churchwide Assembly, and adopting two resolutions. The resolutions were on Compensation and Benefit Guidelines for 2025 and a Reconciling in Christ Welcome Statement. Participants also heard a State of the Synod from Bishop Tessa Moon Leiseth and State of the ELCA from our churchwide representative, Kristen Opalinski. We had two worship services with an emphasis on our indigenous ministries in Opening Worship and care for creation at our Closing Worship with the Rev. Deborah Blood, UCC Conference Minister, preaching. Two keynote presentations were shared by Dr. Kelly Sherman-Conroy, Native Theologian. There were seven workshops offered for participants on a variety of topics. Rostered Ministers and Congregations celebrating significant anniversaries were acknowledged. The Strategic Plan for the Synod was launched thanks to a year-long process of listening and discerning across the synod. A reception was held to celebrate five new Endowment Funds that have been created. The 2025 Synod Assembly will be held on June 7-8 at the Holiday Inn. I would encourage you to consider being a part of this event...as a delegate or as a visitor. As a delegate, you are a part of the decision-making body of the church.

Zion hosted its 14th Annual Thanksgiving Day on November 28, 2024. We offered dine-in, take-out, and delivered meals. At noon 93 people gathered to eat in the fellowship hall; 14 take-out meals were picked up; and 4 meals were delivered. Twenty-one more meals were served at suppertime for a total of 132 meals served. We received \$1420.00 in donations, used \$101.00 to cover expenses (We also had a \$250 Thrivent card to cover expenses.), and have \$1319.00 to donate to Kulm Ambulance. Thank you to everyone involved for making this day such a success!

CHRISTIANS IN ACTION: CHILDREN AND YOUTH REPORT Deacon Tara Longden

"The steadfast love of the Lord never ceases, his mercies never come to an end; they are new every morning; great is your faithfulness."-Lamentations 3:22-23

It is hard to believe that I have been serving the Christians in Action Ministry for over a year and a half. I am continually learning and navigating what my role is as the Director of Children, Youth, and Family for this ministry.

I have been busy teaching and prepping our Bible Confirmation class with Pastor Stephanie which is made up of approximately 30 youth from St. Johns, Trinity, and Atonement. I also prep the Sunday School lessons for Atonement, help coordinate the intergenerational Sunday School lessons on the first Sundays of each month and led this year's Christmas program which was a pop-up Christmas program.

This summer, I led a group of 15 youth and 3 adult leaders as we traveled to the ELCA National Youth Gathering in New Orleans, Louisiana. This group was comprised of youth from English, Medina; Zion, Kulm and Trinity; Jamestown. We had a bit of an adventure on the train getting to New Orleans, but the gathering was a great educational experience for all who attended. Summer worships were held at English in July and at Kulm on September 8th so the youth could share about their experience at the gathering. The next youth gathering will be in Minneapolis, MN in 2027.

Twenty-five youth and four adult leaders attended the annual Eastern ND synod retreat at Castaway Club in Detroit Lakes MN September 20-22nd. These youth were from English, Medina; Atonement, Jamestown; Trinity, Jamestown; and St. John's; Jamestown.

Whenever there is no school in Jamestown, I hold an event at Babb's Coffee House called Coffee and Conversation. It's a laid-back time for youth to come hang out. We discuss questions found through Faith Talk cards. We color, play games, and so much more. I always buy the youth's first drink. Coffee and Conversations were held on October 17, November 11, and December 23 as well as throughout the 2023-2024 school year.

Monthly youth events have been held at Atonement. Two youth have consistently been attending these events. On November, a Friendsgiving event was held. On December 15, a Youth Christmas party was held. Youth played Christmas Name that Tune, Christmas Danger words, and blind-folded gift wrapping. I am continually encouraging these youth to invite other friends to our youth events.

This school year, we also started holding monthly Kids Afternoon Out events at Atonement. We held an October Fall Festival (October 26), November cookie decorating (November 16) and a December Advent party (December 7). There has been a consistent number (10-12 youth) attending these events including some neighborhood children. It is such a joy to watch these events unfold and to see how much fun the kids are having when they attend them.

A Christians in Action event was held at Emmanuel Gackle on September 29th. However, there were only youth from Gackle at that event. CIA events are scheduled through the rest of the year from Jan-May 2025. These events are open to all youth and churches in Christians in Action. In addition, each congregation gets a Deacon Tara led event. Events were held in Gackle on October 13th and in Medina on November 30th as well as several other events last Spring.

In addition to planning several events, I attended a couple of continuing education events: the Synod Vital Conversation titled "Kids These Days" on October 12th and the ELCA Youth Ministry Network Extravaganza in January 2024.

As we continue to learn, grow and navigate our partnerships together, one thing is certain we can truly proclaim God's faithfulness as we share God's love and the message of the Gospel with all God's people!



2025 Christians in Action Board Annual Meeting Report

Christians in Action is a non-profit consisting of Atonement, Trinity and St. John's in Jamestown, Christ the King in Ellendale, Emmanuel in Gackle, English in Medina, Montpelier, and Zion. Meetings are held over Zoom on the first Sunday of the month, from 6:00-7:00 pm with occasional exceptions. Pastor Kristi leads the meetings Officers were elected at the first meeting. Terms are for one year, with the option of re-election. The main purpose of the board is to oversee the operations. Meetings consist of approving financial statements, supporting plans the pastors have in place, and offering up questions and concerns. An annual retreat was held in March (the next one is planned for March 15, 2025 in Gackle) for some face-to-face time among board members. However, anyone is welcome to attend.

Congregations are challenged to create and work on a goal. Zion's goal is increasing young people's participation in worship, through Kids in Sunday Service worship services.

Goals were set at the first retreat and continue to be our focus:

Core Personnel: A single call committee was formed with Christ the King, Emmanuel, Montpelier, and Zion to seek an additional pastor. The congregations can decide how to move forward with the call process. Pastor Erik Weber and Brad Skogen (from synod office) will assist. Atonement continues to search for a pastor. For January 10-February 28, Andrew Stephens will serve as a Synod Lay Minister for Ellendale, Gackle, and Montpelier. Deacon Tara and her husband are moving into the parsonage at Medina.

Sharing Resources: The Treasure Chest of resources is being utilized.

Recruit and Equip Lay Leaders: Each congregation is to recruit members willing to serve as lay minister, local worship leader, local visitation, etc. Specific pastors in CIA will support and train these individuals.

Expand Area Outreach: The guiding question is "How can Christians in Action be more visible in our communities?"

Marketing: The website is NDChristiansAct.org. A facebook page is in the planning stages.

Administration and Support: Details for the non-profit status are being worked out. The wording of electronic files and financial records is changing to simplify the day-to-day operations. (We have a bookkeeper to conduct the financial business who is not an elected board member.)
